NEW BUSINESS

APPROVE PROFESSIONAL SERVICES AGREEMENT WITH HDR ENGINEERING, INC.

A motion was made by Commissioner William Trickey and seconded by Commissioner Norm Lust to approve the "Agreement for Expert Witness Services" with HDR Engineering, Inc. a Nebraska corporation, with principal offices at Omaha, Nebraska, for "expert witness and consulting services in connection with the legal proceeding known as CCRC Reservoir Declaratory Judgment ("Litigation")." PROJECT COORDINATOR REPORT

CCRC Project Coordinator David Beck reported there will be a scheduling conference in Clarke County District Court August 16, 2013. The court administrator decided that due to the complexity of the project that a status conference conducted by a judge was necessary. Dave Beck and Attorney Ivan Webber from Des Moines will attend the 9:30 conference along with responding attorneys. The purpose of the conference is for the judge and attorneys to discuss the status of the project and the amount of time still needed for discovery. A date for discovery to be completed and a date for the actual trial should be set during the August 16 conference. This is a significant piece of progress in the declaratory judgment process. This will be open court so anyone can attend.

Mr. Beck stated he had been working on the plan document basically taking the NRCS May 2011 document and editing out the information not relevant to the project and working on the appendices.

As part of the declaratory judgment process, Mr. Beck explained all landowners were contacted and had the opportunity to respond either directly or through their attorney. There is a Federal requirement for those landowners who did not respond. They must be contacted to determine/confirm they are not currently serving in the military service. There is an affidavit process which has to be completed prior to the judge going into the decision making process concerning the project. The goal is to have this requirement completed by the end of September.

SPONSOR REPORTS

Fred Diehl, City of Osceola, reported Osceola City Council approved to pay for the city of Osceola's portion of the May 7 special election fees with exception of the legal fees. The council wanted an explanation for the legal fees and use of legal counsel.

Sandy Kale, Osceola Water Board, stated she wanted to meet after adjournment with Harold Allen, Jr., Fred Diehl, Larry Keller, and Dave Beck to clarify some project issues.

Frank Riley, Clarke County Conservation Board, reported that Anita Foland retired on July 26, 2013 after serving for 22 years as Director of the Clarke County Conservation Board. Currently board member Dixie Rinner will serve as the alternate. After a new director is hired, the CCCB will determine the board's representative for the Clarke County Reservoir Commission.

Norm Lust, Clarke Soil & Water Conservation District, reported that as the lake plan develops, the Natural Resource Conservation Service and Soil and Water Conservation Districts will provide technicians from

four surrounding counties to assist with design and application of land practices around the lake and cost share programs for the area.

There were no other reports presented.
